

NFL on SEN TIPPING COMPETITION 2026 -2027. TERMS AND CONDITIONS.

The following terms and conditions (the “Terms and Conditions”) set out the contest rules for the NFL on SEN Tipping Competition 2026-2027, held by Sports Entertainment Network Pty Ltd, ABN 63 129 637 378, Level 5, 111 Coventry Street Southbank VIC 3006 (hereinafter referred to as “the Promotion”) and TAB (hereinafter referred to as “the Promotional Partner”).

Promotion Period	Start Date: Entrants may register for the Promotion from 5:00pm (AEST) on Thursday 13th August 2026,. The Promoter reserves the right to tease the promotion prior to the competition start date. End Date: The Promotion Period ends at of the conclusion of the 2026 NFL Regular Home & Away Season or 11:59pm (AEST) on Monday 11th January 2027. The Promoter reserves the right to: - Amend the contesting period at its absolute discretion including to close the competition within the Promotion Period. - Terminate the competition subject to any direction from a regulatory authority.
Draw Date	Minor/Weekly Prizes: One (1) Minor, Weekly prize will be determined on or before 5:00pm (AEST) on the Wednesday after the completion of each round of the NFL Regular (Home & Away) Season (each a “Round”) at the Promoter’s Premises. The minor, weekly prize winner will be notified by phone or e-mail details set out in the contact details provided in the winner’s registered account by 2:00pm (AEST) on the Thursday after the completion of the relevant Round.

	Major Prize: The sole Major Prize will be the one (1) major end of season prize that will be determined at the Promoter's Premises on the day that is two days after the End Date at 2:00pm (AEST). The sole Prize winner will be notified via the phone or e-mail details set out in the contact details provided in the winner's registered account by 2:00pm (AEST) on the day after the determination of the winner of the Major Prize.
Redraw Date (if necessary)	Minor/Weekly Prizes: If, after making reasonable efforts to contact the winning Entrant on the contact details provided in the winning Entrant's registered account, the winning Entrant cannot be contacted by 5:00pm (AEST) on the Friday after the completion of the relevant Round, the unclaimed minor, weekly Prize will be re-awarded, no later than at 12:00pm (AEST) on the day that is two business days later, to the runner up Entrant, who will be determined and then notified as soon as practicable. The runner-up will be determined using the same process as that used to determine the original winning Entrant. Major Prize: If, after making reasonable efforts to contact the winning Entrant on the contact details provided in the winning Entrant's registered account, the winning Entrant cannot be contacted by 5:00pm (AEST) Friday 22nd January 2027, then subject to any written directions from a regulatory authority, the unclaimed Major Prize will be re-awarded, no later than at 12:00pm (AEST) on the day that is two business days later, to the runner up Entrant, who will be determined and then notified as soon as practicable. The runner-up will be determined using the same process as that used to determine the original winning Entrant.

	phone number and email address), and registering for NFL on SEN 2026 Competition. At completion and submission of the online registration form, Entrants agree to be contacted by the Promoter and any third party associated with the Promotion for the purposes of conducting the Promotion. They must also submit and save the winning margin for the first scheduled game of each Round as specified by the Promoter on the Promoter's Website before the start (kickoff) of that game (the "First NFL Game") to be deemed a valid entry.
Limitations on entries	There is a limit of one (1) entry per Entrant throughout the Competition Period. Any attempt by any Entrant to obtain more than one (1) entry through multiple/different email addresses, names, phone numbers or addresses will void that Entrant's entries and the Entrant will be ineligible to win the prize as determined at the Promoter's sole and absolute discretion.
Minor/Weekly Prize	There will be one Minor, Weekly prize to be won at the completion of each Round (i.e., 18 in total if there are 18 Rounds), subject to the Terms and Conditions. The Minor, Weekly prizes are: - \$100 Sporting Globe Voucher Separate Gift Card, e-voucher or General Admission ticket terms & conditions may apply. The total value of all the minor, weekly prizes (assuming all 18 Rounds are played) is up to AUD\$1,800 (including GST).

The Minor, weekly prizes will be awarded to the Entrant who has scored the highest number of points at the completion of the relevant Round, with the lowest margin differential on the first NFL game of that Round. Scoring is calculated each Round as calculated and determined by the Promoter based on the following points scoring summary:

Other important information – Minor/Weekly Prizes

If two (2) or more Entrants have the same number of points at the completion of the relevant Round, and the same lowest margin differential on the First NFL Game of that Round, so there is not one unique winner, the Entrant who registered for this Promotion first in time (of the eligible Entrants that have been assessed against the scoring criteria) will be ranked higher in order to break the tie and will be deemed the winner of the minor, weekly prize.

If an Entrant does not submit a tip for a game in any Round, that Entrant's tip will be deemed to be for the away team as detailed by the NFL.

Please note a user can only receive a maximum of 5 correct default selections in any Round.

Where a game in any Round is drawn, cancelled, abandoned, not completed or not played for any reason and a result is not officially declared by the NFL or within three (3) days of the completion of that Round, that game will be deemed to be a win for both teams playing in that game, and a correct tip awarded to each Entrant for the purposes of awarding the minor, weekly prize.

If the Entrant does not submit a winning margin on the First NFL Game of the Round, then that Entrant's default margin will be 7 points, as determined by the Promoter in its sole and absolute discretion.

Major Prize	There is one (1) x Major Prize to be won at the completion of the Promotion, subject to the Terms and Conditions, namely \$5,000 paid into a valid bank account owned by the winner. The total value of the Major Prize is AUD\$5,000. (including GST). The winning Entrant must provide a valid, Australian bank account. The winning Entrant must provide the Promoter with all information and documentation requested and necessary to enable the Promoter to register the Major Prize in the name of the winning Entrant prior to collecting the Major Prize. 	lowest cumulative margin difference for the NFL Regular Home & Away Season, being the difference between the Entrant's submitted margin for the selected First NFL Matches in each Round and the actual margin of the First NFL Matches in each Round as determined by the Promoter in its sole and absolute discretion. If, after assessing the lowest cumulative margin difference above, there is not one unique winner, the Entrant who registered for this Promotion first in time (of the eligible Entrants that have been assessed against the scoring criteria) will be ranked higher in order to break the tie and will be deemed the winner of the Major Prize. If an Entrant does not submit a tip for a game in any Round, that Entrant's tip will be deemed to be for the away team as determined by the NFL . <i>Please note a user can only receive a maximum of 5 correct default selections in any Round.</i> Where a game in any Round is drawn, cancelled, abandoned, not completed, or not played for any reason and a result is not officially declared by the NFL within three (3) days of the completion of that Round, that game will be deemed to be a win for both teams playing in that game, and a correct tip awarded to each Entrant for the purposes of awarding the Major Prize. Total Prize Pool	The total value of all minor, weekly prizes and the Major Prize for the NFL on SEN 2026 - 2027 Competition is \$6,800 (including GST).
Publication Details	Winner/s of all prizes (minor, weekly prizes and the Major Prize) will be published on the Promoter's Website from the time of notification by the Promoter to the winning Entrant for a period of no less than twenty-eight (28) days.

By submitting a valid Entry, the Entrant acknowledges and agrees to be bound by the Terms and Conditions.

Introduction

1. The above table forms part of these Terms and Conditions and contains details concerning when, who and how to enter, the time, place and method of prize selection, prize details and who the Promoter is and any permit details.
2. Employees of the Promoter and agencies associated with this Promotion, and their respective immediate families, are ineligible to enter the Promotion. For clarity, "immediate families" includes any of the following: spouse, child or stepchild, parent, stepparent, grandparent, step-grandparent, brother, sister, stepbrother or stepsister.
3. Participation in the Promotion is deemed acceptance of these Terms and Conditions. By entering, the Entrant warrants that they have read, understood, and accepted these Terms and Conditions.
4. Subject to any applicable laws, the Terms and Conditions may be updated or amended by the Promoter at any time and no notice of the updated or amended Terms and Conditions is required to be provided to Entrants.
5. Entries not completed in accordance with these Terms and Conditions are void. Entries will be deemed void if stolen, forged, mutilated, or tampered with in any way. The Promoter will take all necessary steps to ensure that entries are properly recorded and stored but will accept no liability if an entry is not recorded or is lost.

Further Entry Conditions

6. Entries to the Promotion are limited to one per Entrant.
7. The Promoter may remove any and all unauthorised multiple entries.
8. Entries will be deemed accepted once completed and at the Promoter's absolute discretion. The Promoter will be in no way responsible for incorrect or insufficient details provided by any Entrant. Should an Entrant's details change, it is the responsibility of the Entrant to provide these details to the Promoter.
9. Neither the Promoter nor any third party involved in the Promotion will accept any responsibility for, and nor will they be liable in any way for, an Entrant's late, lost, incomplete, misdirected, incorrectly submitted, or delayed entry into the Promotion, whether or not due to, but not limited to, any error, hackers, failure of any electronic or other communications equipment, computer transmission and/or network connections. See further Term 23 below.
10. Neither the Promoter nor any third party involved in the Promotion will accept any responsibility for, and nor will they be liable in any way for, an Entrant's late, lost, incomplete, misdirected, incorrectly submitted, or delayed entry into the Promotion, whether or not due to, but not limited to, any error, hackers, failure of any electronic or other communications equipment, computer transmission and/or network connections. See further Term 22 below.

11. Incomplete, indecipherable, or illegible entries or those that contain offensive or defamatory comments or that breach any law or infringe any third-party rights, including intellectual property rights, will be deemed invalid. Errors and omissions may be accepted at the Promoter's absolute discretion and the Promoter's decision on this, and other aspects of the Promotion is final, and no further correspondence will be entered into. Any failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

12. If there is a dispute as to the identity of an Entrant, the Promoter reserves the right in its sole discretion, to determine the identity of the Entrant. For the avoidance of doubt, the Promoter is responsible for determining whether a person is an eligible Entrant in its absolute discretion.

Prizes and Awarding of Prizes

13. The prize-winner will be notified by the Promoter by e-mail and the winner's name, and suburb and other details may also be published on the SEN website (sentipping.com.au) using details forming part of the Entry.

14. The Promoter will advise the winner about how and when they are to accept their prize. If for any reason a prize remains unclaimed by the Redraw Date, their prize will be forfeited, and the Promoter reserves the right to re-award the prize in accordance with these Terms and Conditions.

15. The Promoter is not responsible if the prize (including any physical or electronic tickets forming the prize) is late, lost or misdirected. The prizes (or any used or unused portion thereof) are not transferable, exchangeable, or redeemable for cash. If the prize winner is unable to take or use any element or portion of the prize for any reason, that element or portion will be forfeited, and no compensation or substitute prize will be provided unless otherwise determined by the Promoter in its sole and absolute discretion. It is a condition of accepting a prize that the winner must comply with all the conditions of use of that prize and the prize supplier's requirements as well as all these Terms and Conditions.

16. If a prize or any parts of a prize are unavailable, for any reason, the Promoter, in its discretion, reserves the right to substitute that prize or parts of that prize with a different prize or different parts of that prize to the equal or near equal value and/or specification and/or an alternative date, subject to the written directions of any regulatory authority.

17. The prize value is in Australian dollars inclusive of GST and is based on the normal retail value of the prize components at the time of publication (online or otherwise). The Promoter accepts no responsibility for any variation in the value of any prize. The Promoter accepts no responsibility for any tax implications that may arise from the prize winning and independent financial advice should be sought.

18. To the extent permitted by law: (a) the Promoter makes no representations or warranties as to the suitability of any prize; and (b) no compensation will be payable if, for any reason, a winner is unable to use the prize as stated.

20. As a condition of accepting the prize, the winner may be required to sign legal documentation as and, in the form, required by the Promoter and/or prize suppliers in their absolute discretion, including but not limited to a legal release and indemnity form.

General

21. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law, to disqualify any Entrant or to modify, suspend, terminate, or cancel the Promotion, as appropriate.

22. The Promoter will not be liable for any loss or damage whatsoever (including but not limited to indirect or consequential loss) or personal injury suffered or sustained arising from or in connection with the Promotion, any omission to enter a person into the Promotion, acceptance of the prize or the prize itself, except for liability that cannot be excluded by law.

23. The Promoter assumes no responsibility for any error, omission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries. The Promoter is not responsible for any problems or technical malfunction of any equipment, software, failure of any email or entry to be received by the Promoter on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to any Entrant or any other person's computer related to or resulting from participation or downloading any materials in this Promotion.

24. Entrants are providing information to the Promoter and not to the social channel, including Instagram or Facebook.

27. TAB's involvement in the Promotion is limited to its role as Promotional Partner. TAB is not responsible for the administration, conduct or operation of the Promotion, including the collection of entries, determination of winners or fulfilment of prizes, which remain the responsibility of the Promoter.
